1. When the team advancing the ball fails to notify the officials from which side of the playing court they will make the throw-in before the timeout is reported to the table, the throw-in will be made at the 28 foot mark on the table side. Is this correct?

In 31-50, “C” is for correct and “I” is for incorrect.

31. B1 has the ball for a throw-in on her baseline (in her frontcourt). B1 throws the ball into her backcourt where B2 gets the ball. This is legal play.

32. A3 has just committed her 5th personal foul in the game. The coach for Team A will be given 20 seconds to replace her.

33. A3 shoots the ball. The ball misses the rim/flange and backboard. A3 follows her shot and grabs the ball before it hits the floor. Play is allowed to continue.

38. A1 has the ball at her disposal for a throw-in. The head coach of Team B calls for a time-out. The official grants the time-out.

39. A1 is fouled by B1 and is entitled to two (2) free throws. Before the ball is bounced to A1, Team A's coach is assessed a direct technical foul. Team B will shoot 2 free throws for the technical foul, and then A1 shall attempt the first shot of her two shot foul since that was the point of interruption.

40. A1 is dribbling the ball when she tries to end her dribble by catching the ball with two hands. She fumbles the ball and it rolls away from her. She runs 3 steps and recovers the ball. This is a legal play.

41. During an interrupted dribble, there shall be no player control and a timeout may not be granted.

42. After coming to a stop and establishing a pivot foot, A1 lifts her pivot foot, but does not put it down. The official blows the whistle and calls a traveling violation.
